#### **Relationship and Association Commission**

Recent highlights from the Relationship and Association Commission:

- Representatives of different forms of membership and association gave detailed information about the inquiry and candidacy/formation process currently in place for Sisters, Consociates, Friends of St Joseph, and Agrégées.
- As a group, we explored how we can better collaborate, support inquirers and candidates in formation, and find ways to invite others into this work of hospitality.
- Commission members have had deep conversations about the kind of exciting work we might be called to do as a commission. We dedicated lots of meeting time to dream and brainstorm together about what might be possible. The ideas we generated helped us become even more clear about what we might be best positioned to do in the CSJ Community. Committee members are currently discerning where their energy and passion might be leading them for personal involvement.
- In the past few months, subcommittees have worked to strengthen relationships between the CSJ Community and partners. Examples include the evolution of the CSJ/St Kate's Food Access Hub (<u>https://www.csjstpaul.org/celestes-dream/food-access-hub/</u>) and ongoing communication with organizations founded in the CSJ Mission.
